## Guest Pass Policy Release and Liability Waiver –Effective January 2022

Members in good standing may purchase a 'Guest Pass' stamp for \$10 per year at the time of membership renewal only. The stamp will be placed on your membership card to indicate your participation in this program. Your card must be displayed and guests must be under the direct supervision of their host member at all times as members are responsible for the conduct of their guests while on club property. Host members with guests should be considerate of interfering other members using the facilities.

Members who purchase a guest pass are limited to a maximum of **(3) guests per visit**. A guest is permitted to use club facilities a maximum of (3) times after which they should join as a member. Guests may use the pond but may not keep fish (catch and release only). Members may not use the Guest Pass for commercial purposes including charging guests for admission or firearm training purposes. Guests must complete and sign the Guest Release and Liability Waiver **prior to using the facilities**. Detach and display the bottom portion while using club facilities and deposit the top portion in the box at the club entrance.

*I understand and accept the fact that Cocalico Sportsmen's Association is a sportsmen's club that includes the shooting of firearms, bows and arrows, as well as a fish pond. The activities carried out at the club have many dangers and risks, including personal injury, death or property damage. I (and my minor child listed below) agree to abide by the rules and safety precautions associated with any activities undertaken while using any of the clubs facilities and understand that due to the nature of this activity, willful disregard of rules and safety precautions may result in dismissal from the premises. In consideration of my (or my minor child's) involvement with the Cocalico Sportsmen's Association and its affiliated activities, I, intending to be legally bound, represent, acknowledge, and agree that I (or my minor child) have voluntarily chosen to participate in club related activities and do so entirely at my/his/her own risk. I acknowledge that Cocalico Sportsmen's Association makes no representations concerning the safety of any activity, the facilities, or other participants.*

**I UNDERSTAND THAT ENGAGING IN FIREARMS SHOOTING ACTIVITIES CONSTITUTES INVOLVEMENT IN A HAZARDOUS AND DANGEROUS ACTIVITY WITH ACCOMPANYING RISKS OF PERSONAL INJURY OR DEATH AND LOSS OR DAMAGE TO PERSONAL PROPERTY, AND HEREBY VOLUNTARILY ASSUME THOSE RISKS.**

*I hereby release, waive, discharge, and hold Cocalico Sportsmen's Association, its officers, directors, agents and members, harmless from all liability for any loss, damage, or injury (including death) to myself, and on behalf of the minor child as parent/legal guardian, or to any other person or property arising in any way out of my and/or the minor child's participation, including liability, loss, damages, or injury caused in whole or in part by the negligence or carelessness of Cocalico Sportsmen's Association, its officers and directors, and its volunteer workers. I further covenant not to sue Cocalico Sportsmen's Association for any such loss, damages, or injury (including death). This release shall be binding on me, the minor child, our personal representatives, heirs, successors and assigns. I agree that this Release shall be governed by the laws of the Commonwealth of Pennsylvania.*
